For unrestricted funds, a small portion of the revenues are held back, off-the-top, for SELPA operations and reserves, based on the most recent adjusted ADA, then the remainder is distributed to the LEAs, based also on ADA. Restricted and designated funds are held back and distributed based on their intended use. Out-of-Home funds are used for students who qualify for out-of-home status, and pay for student placements in group homes and/or specific regional programs. Preschool funds are distributed to districts with special education preschool students, on a perstudent basis. Subsidies for additional regional program placements, legal fees, extraordinary costs, and special education transportation for qualifying students. Low incidence funds are distributed to LEAs based on need for low incidence equipment. IDEA funds are distributed to LEAs with a base rate based on percentage of pupil count by District of Service (Reporting LEA), a portion is distributed based on K-12 percentage of enrollment (population), a portion is distributed based on percentage of free or reduced price meals (poverty), and proportionate share for private schools.

- 4. Costs of special education services to pupils with nonsevere disabilities. (This population is identified by the goal field.)
- 5. Costs of supplemental aids and services provided to meet the individual needs of pupils placed in regular education classrooms and environments. (Costs of these aids and services are tracked in the function field.)
- 6. Costs of regionalized operations and services and direct instructional support by program specialists in accordance with Part 30, Chapter 7.2, Article 6, of the California *EC*, Program Specialists and Administration of Regionalized Operations and Services. (These costs are tracked in the goal field for regionalized operations and in the function field for instructional services.)
- 7. Use of property taxes allocated to the SELPA pursuant to EC Section 2572. (Property taxes allocated to the SELPA are tracked in the resource field and identified by a revenue code in the object field.)
